#### **Summer Tournaments**

It was decided that the summer tournament will be held at the Causeway Club on May 10<sup>th</sup> and 11<sup>th</sup> with the following age groups. Under 12s, Under 10s, Under 9s, Under 8s, Under 7s & Under 6s.

Entry will be £30 per team with all funds from team entries and car parking to Cinderford Town youth and profits from food and drink to Cinderford Town.

Entry in all other summer tournaments must be agreed by the treasurer prior to entry. The club will then arrange for the payment to be sent along with the application form.

#### **End of Season Presentation Night**

Dates were confirmed as Saturday April 19<sup>th</sup> for the Under 14s, Under 12s & Under 10s and Sunday April 20<sup>th</sup> for the Under 9s, Under 8s, Under 7s, Under 6s and Under 5s. It was decided that each league team will have trophies for "Manager's Player of the Season", "Opposition Player of the Season" and "Parent's Player of the Season"

## **Parents vs Coaches Game**

No date has been set for the parents vs coaches game as yet due to the ongoing weather problems. It will be looked at again around April time and potentially on a Saturday evening after a Cinderford Town game.

## **Next Season**

### **Teams**

No final decision will be made on teams until the summer. All teams will enter the Cinderford Town tournament as this season and decisions will be made in May.

### **Training**

It was decided to look at block booking the Astroturf for all age groups on the same day if possible. Day to be discussed with the coaches at the next coaches meeting.

### **New Policies**

- 1) From 2014/2015 players **MUST** attend training to be selected for games unless it's to the detriment of the side. Players missing occasional weeks will not be penalised, only those continually missing training.
- 2) From 2014/2015 managers should only manage one side unless agreed by the committee
- 3) From 2014/2015 any player owing more than £10 to the club (in match fees, training fees etc) should not play for the club until the money is paid unless to the detriment of the club.
- 4) From 2014/2015 all spending by each team should be cleared by the treasurer prior to agreeing to anything. This should include training costs, equipment etc and receipts **MUST** be provided for all money spent.
- 5) From 2014/2015 all coaches should hand in match fees and training money **AT LEAST** once a month

## **Pitches**

Rich Wilkins to discuss a potential new pitch for the under 12 team with Cinderford town council. Rich to also discuss continuing to use Forest View school and Forest E-Act academy with the relevant people.

## **Leagues**
